1. Welcome & Apologies

The Chairman opened the meeting.

2. Organisational Announcements /New Members

There were no organisational announcements or new members to make the committee aware of.

3. LBA:Regen

Charles Johnson provided the committee with a PowerPoint update on the terminal extension. Since the last meeting, work has continued above ground level. The steelwork is being erected and everything is currently progressing as expected and is on programme.

Work has commenced on the offsite drainage upgrade which is expected to take approximately 16 weeks to complete. During this time, there maybe some disruption to the highway on Whitehouse Lane.

The next stage is looking at the fit out of the extension as well as ORAT (Operational Readiness, Activation and Transition) for when the development goes live.

- Q. Are you on schedule?
- A. Yes, we are on schedule and on budget.
- Q. When does the phase 2 tender start?
- A. We are looking to commence this in Autumn 24.
- Q. How many extra jobs has the building work created?
- A. Not entirely sure, we will check with Farrans and share this information.

John Cunliffe advised there will be 70% extra space for retail units with additional free seating available.

The lounges will be repositioned and will also increase in size.

- Q. Will there be an option for a business traveller lounge?
- A. The Runway 1432 lounge does not allow children however, both lounges cater for business travellers.
- Q. Do you have anything to do with the South Side, they have been looking to expand for a long time.
- A. Multiflight are a tenant of LBA, They have expressed an interest over the years in expanding but have never progressed plans.
- Q. Would it be possible to consider a more healthy eating option?
- A. People do sometimes ask for healthier options but in reality when people are going on their holiday the majority don't want healthier, and are more inclined to treat themselves.

4. LBA Brand

John Cunliffe presented to the committee the airports brand refresh which have seen some slight changes to the logo. In addition, the latest marketing campaign 'Ey Up World' has been launched. There is an advertising campaign with various advertisements relating to Ey Up World.

- Q. Travel agents do not seem good at promoting LBA.
- A. Yes, we would tend to agree, trade do seem fairly negative about LBA. It is an area that we are working on to improve.
- Q. What were the trade saying to you as to why they don't promote LBA?
- A. It was a mixture of weather issues, surface access and business routes.
- Q. How do you change the perception of the weather?
- A. It's hard, perception is engraved but we are working on changes those perceptions.
- Q. Are you talking to Tour Operators?
- A. We are engaging with all Tour Operators and have a dedicated member of the team dedicated to speaking with the travel trade.
- Q. Re Diversions, what would you consider as an acceptable diversion rate?
- A. We want zero diversions. However, sometimes we do have diversions. It is a difficult one to rate.
- Q. Do you know anything about Doncaster reopening this Summer?
- A. We are not involved, so don't have any additional insight into the matter.

5. Aviation Update

In the absence of Nicola McMullen, John Cunliffe continued to provide an update on Aviation to the committee.

The new c3 scanners are now fully operational in security. We are pleased to report that the implementation was in advance of the official deadline. Initially we had experienced some short term queues however, we are now seeing an improved wait time to get through security.

Wizzair continue to experience some Pratt & Witney engine issues which has caused some disruption to their operation.

Ryanair's third based aircraft was deployed to LBA a little later than expected impacting on passenger numbers.

Easyjet have launched a new 6x weekly route to Geneva and Jet2 have announced a new route to Jerez which will commence May 2025.

- Q. KLM are not using their own aircraft
- A. We have seen some other aircraft for KLM. They have experienced some issues with the Embraer engines.
- Q. Any news on a London flight?
- A. Not at the moment, we are continuously in talks with airlines.
- Q. Any update on the Parkway Station?
- A. No further update, Network Rail are still working on timetable issues.
- Q. Any update on the ACP progress?
