This will be achieved by complying with all applicable legislation and applying best available techniques, wherever possible.

| Environmental Auditing                     | Maintain and improve environmental standards by auditing and monitoring procedures and practices.   |
| Employee Awareness                         | Promote sustainable working practices and develop employee awareness by ensuring that all employees take into account environmental consequences of their work and are made aware of their individual responsibility. |
